After lunch the speakers will tackle the use of 30 MHz sensing tech-








nology for the improvement of environmental control, biopesticides in propagation and techniques for management of the aerial environ-(Continued on page 4)

This is a massive issue in which growers will be investing huge amounts of money."

Seasonal Workers/ Labour shortage -

The association, with other horticulture interests in the NFU, made strong representation to the government to retain the SAWS since 2014, Seasonal Agricultural Workers Scheme. This scheme which gave time limited licensed contracts to overseas workers, with a return to country of origin at the end has been abandoned in favour of an open EU labour market. Recent announcements thanks to NFU lobbying has had this type of scheme reintroduced on a trial basis and we are pleased one of our own members is helping lead this scheme together with the Home Office.

Xylella -

This continues to be top of the agenda in many meetings on biose-

curity. There is no hard solution other than to continue to source our plant material responsibly and ethically.

Brexit -

While we lead in to Christmas with a PM in place at least and a date that the UK exits the EU, there is still so much uncertainty. The NFU are working hard on the industries behalf to secure our policies, strengthen our position and ensure our voices are heard in our concerns for imports, the volatility of the Pound and labour shortages.

The BPOA continues to be active in supporting the ornamentals sector and participating in action to promote the interests of growers; we will continue to inform both advisory and legislative bodies of our concerns. The BPOA continues its policy that our events offer members great value for money and will endeavour to maintain this position.

The first poinsettia discussion meetings organsed by AHDB was held at Neame Lea nurseries on 22nd November with a very good turnout from the industry wanting to see the developments in the

testing. In addition to the talks in the greenhouse from Mark Else on growth control using deficit irrigation, 30Mhz and Vasile from Neame Lea on his trial.

work already commenced last season to find new and better ways of regulating the size of the poinsettia crop. This was followed by the initial scoring by the whole growers' group of the trial plants brought in for shelf life

ment. Altogether, a review and update of the many areas to be considered in grower managed young plant production.



Poinsettia Shelf life trials

AHDB Poinsettia variety trial and continued evaluation of deficit irrigation strategies to control growth - 17 January 2019, Lincoln University, Holbeach, Lincolnshire.

This event, the second in the series of Poinsettia Discussion Forums will include a summary of the poinsettia study tour to Italy and post-shelf life evaluations of the poinsettia varieties in trial.

From the earlier scoring at the point of entry to shelf life conducted at the day in Neame lea in November, a final assessment is now being made which will show up varietal differences in the trials and possible phytotoxicity of the new chemicals and combination treatments.

Latina Study Tour

This autumn the study tour took the opportunity to visit the area of Lazio, south of Rome, where there is a large scale production of ornamental plants and in particular at this time of the year many poinsettia and cyclamen. Much of the current horticultural production is under polythene structures with some glass and a large area of outdoor production for 'mediterranean plants'. The large companies that we visited, some of the 90+ producers in the area, extended to many hectares of covered and uncovered nurseries with a wide range of pot crops focusing on annual plants in the early part of the year followed by large cyclamen and even larger poinsettias. About 17M poinsettias are grown in Italy and a large percentage (3M+) in the Latina area. Many of these plants are large size and so the total turnover in the poinsettia production industry could be as much as €110M! There is some discussion about the European league status of Italy in terms of numbers of plants grown but in relation to the turnover of the

Germany.
